

President's Safe Driver Club Rules

A nominee for membership in the President's Safe Driver Club (PSDC) must be a driver working for a Wisconsin Motor Carriers Association member company. The driver must be:

1. a full-time employee or permanent leased operator who lives and drives in Wisconsin;
- or**
2. a full-time employee or permanent leased operator reporting to or being dispatched from a terminal within the State of Wisconsin who drives a minimum of 10,000 miles on the public streets or highways of Wisconsin annually.

How may the driver qualify for membership in PSDC?

1. The driver must have 36 continuous months of service with the same employer as of March 31, 2017, to qualify for the *first year* of membership in PSDC. In addition, the driver must have:
 - A. No accident, whether on or off duty.
The only accidents which need not be counted against the driver's record are when:
 - 1) the driver's vehicle was legally and properly parked.
 - 2) the driver's vehicle was stopped in traffic in compliance with a traffic sign or signal or under the direction of a police officer.
 - 3) the driver hits an animal and the damage is limited to the animal hit.
 - B. A clean Motor Vehicle Record indicating no traffic citations, whether on or off duty.
2. Driver must be nominated for PSDC membership by a company official. Nomination forms will be supplied through the WMCA office and upon return must be accompanied by the **driver's current MVR (dated after March 31, 2017)**.
3. **After initial membership has been earned**, the driver may accrue additional credits for each consecutive year of safe driving under compliance with these rules. Special 5-, 10-, 15-, and 20-year award will be presented.
4. If the member should have an accident or a citation within a reporting 12-month period, he/she will lose that particular year toward accrued continuous years of membership. The driver will not lose the years accrued prior to that reporting period. Three citations or three accidents in one reporting year will result in disqualification from membership.
5. After earning membership in PSDC, if the driver should have two consecutive years of failing to meet the requirements for continuation of membership, he/she would be disqualified from the club and have to go through the original three-year probation period to regain admittance.
